**DISCUSSION ITEMS:**

A staff report was presented by Cooling.

**Nature Center Naming Rights.** Board members discussed the requirements of naming rights for the Nature Center. Members talked about how to think about the new design and lower costs associated with it relative to a percentage of the total that should be expected to retain those naming rights. To be able to get an accurate understanding of what that might look like, Board Members want to have the updated cost estimate in front of us. After we have that, the board can come up with a number that would be required to retain those rights. Van Zante will write a letter to the King family expressing this decision.

**MARIPOSA ROAD- ACTION 22-57.** Manatt’s bid the seal coat road at Mariposa several different ways. Board members decided to start with just the portion from the back gate and around the campground loop, adding rock and then a double seal coat. Motion by Smith, second by Herbold to add rock to fill in ruts (\$3,503.50) and then a double seal coat (\$29,962.17) around the campground loop for a total project cost of \$33,465.17. Motion carried unanimously.
